La Pryor ISD News:

Bulldog Strong. Safe. Start.

Based on county COVID-19 numbers including La Pryor cases, feedback from teachers and feedback from parents, LPISD will be proposing the following dates for the 2020-2021 school year:

July 27th - July 30th, Online Registration for all students

August 19th - Teachers begin preparation for the school year

August 31st - First day of school

August 31st - September 25th, All students enrolled in remote online instruction. (First 4 weeks)

September 11th - Deadline for parents to choose either on campus instruction or to continue with remote instruction. Once the decision is made, students cannot change methods of instruction until the 6 weeks grading cycle is over.

September 28th - First day of on campus instruction for students that elect to be on campus. All CDC guidelines will be followed on all campuses. Based on numbers, the possibility for all students to continue with remote learning might take place. We will be looking at the percentage of positive tests and make a decision on allowing on campus instruction to take place. The school board or local health authority could extend the remote only option for four more weeks if necessary,

June 11th - Senior Graduation

The safety of our students, staff and community will always be our number one priority. LPISD will be releasing our Strong. Safe. Start. guidelines to the public in the next few days.
